2 Current state of work

The WP1 Team has activated on January 31, 2023, a webpage dedicated to an overview of the Project TIMES on the official Coordinator website (CNIT). General information about the mission, the objectives and the duration of the project are displayed. The Partners forming the Consortium are listed. Among the information, the project first liaisons and news are already available.

The webpage is available at this link (https://wilab.cnit.it/times/).

2.1 Complications

The active webpage at the present day is a temporary one.

As already acknowledged by the European Commission, the WP1 Team encountered a communication issue at the beginning of the activity with the Project Officer assigned. This led to a delay in the project domain purchase due to a lack of information.

While waiting for further instructions, the WP1 Team opted to create a simplified webpage on the Coordinator's website as a temporary solution. The webpage (https://wilab.cnit.it/times/) was published on January 31, 2023.

After a discussion with the European Commission, the Scientific Coordinator, Prof. Luca Sanguinetti, was notified by Bernard Barani and Pavlos Fournogerakis that a new Officer would have been assigned to the Project during the ETSI RESEARCH CONFERENCE in Nice (FR), precisely on February 9, 2023.

The new project Officer, Ms Oana Radu, set a fluent work discussion. The first action points were initialised, such as purchasing the project domain and the security certificates. The domain with which the website will be developed is times6g.eu.



3 Implementation

As mentioned in the previous section, the current webpage is temporary. Nevertheless, the Consortium has already overseen and approved the finalised structure that will be requested to a web developer. The approval took place in the Kick-Off Meeting on January 19, 2023.

3.1 Project Website structure

The website will be divided into two main areas: *i*) a public area, accessible by everyone, and *ii*) a private area, accessible only by registered users.

Regarding the public area, the TIMES website home page will present the public information about the project:

- a short description of the project, underlining the objectives and key ideas;
- a short description of the core activities;
- latest news and events about the project activities;
- the outcomes that can be published of the project;
- the list of the partners composing the Consortium and their logos;
- the main contact of the reference people;
- the access to the private area.

Further details about the communication and dissemination activities and the scientific publications will be accessible through the website's "News & Events" and "Outcomes" sections.

The WP1 Team will design the layout and maintain the public website content in collaboration with all partners and under the supervision of WP7 Team.

After logging in, registered users may access the following additional pages and/or contents:

- *Profile:* this section allows users to change their profile information (e.g., password, username, email address, etc.)
- Deliverables & Relevant Documents (FTP Repository): it shows the project final deliverables and relevant documents.
- Events & Meetings Registrations: a section allowing all partners to register for all events, internal or external meetings or dissemination activities.
- Calendar: it displays the list of the scheduled important dates.

Other sections, both in the public and the private areas, can be added, if necessary, following the request of the WP Leaders to the PMT.

All the events on the calendar will have a pop-up window that appears only when the cursor is on top of the event. The pop-up should show the basic info of the event: title, venue, and dates.

In case of events open for registration, the pop-up should include a "sign up now" button.

4 Further actions

Based on the second quotation for the development of the website, the Consortium will be able to decide between the two web developers to whom to refer.



Future wireless networks are envisioned to support novel applications that require similar performance as wired networks in terms of data rate (Tbps), ultra-low-latency (well below 1 ms), sensing (e.g., mm-level localization accuracy), and reliability (e.g., 1 in a billion transmission error). The current 5G approaches have a hard time keeping up with such envisioned applications. TIMES addresses this problem by combining novel radio channel propagation measurements and modeling approaches, spectrally efficient and reliable communications at Terahertz (THz) spectrum bands with intelligent mesh networking protocols and smart sensing and shaping of the propagation environment through reconfigurable metasurfaces.



While the fundamental technologies developed will be applicable to different beyond-5G scenarios, TIMES will focus on an industrial setting, since many of the envisioned applications in this complex scenario (e.g., cooperative robots, predictive maintenance, real-time closed-loop control) require concurrent high performance, reliability, and sensing capabilities. To tackle the challenge, TIMES extends the state-of-the-art on three fronts: 1) Propagation channel measurements and characterization in THz bands, including measurement and modeling of meta-surfaces and electromagnetic leakage in complex scenarios; 2) Developing technological enablers for reliable THz communications (e.g., smart beam management, ultra-massive MIMO, THz-tailored PHY and MAC design, meta-surfaces, and new mesh-based architecture); and 3) Implementation of a THz mesh network prototype, including design and fabrication of both active (transceivers) and passive (meta-surface) nodes, to validate selected technological enablers developed in TIMES.
